- Certification of Eligibility for home loan guaranty
- Outpatient treatment for: (1) service-connected conditions, and (2) for all medical conditions if enrolled in VA Health Care Program. Co-pay for treatment may apply for non-service-connected conditions
- Service Disabled Veterans insurance (Maximum of \$10,000 coverage) must file within 2 years from date of new service connection
- Travel allowance for scheduled appointments for care of service-connected disabilities at VA
- 10-point Civil Service Preference
- Clothing allowances for eligible veterans
- Prosthetic Devices for service-connected conditions
- Temporary total evaluation (100%) based on hospitalization for a service-connected disability in excess of 21 days; or surgical treatment for a service-connected disability necessitating at least 1 month of convalescence
